It is essential that each participant have a good understanding of the and resource management practices implemented, other participants. The purpose of the presentation is to establish a "safe space" of common understanding, maintain this information available for other participants to evaluate.

In order to see the presentation, please consider what you would want to know about, or on operation, or where another participant decides what the other's trust to place in interaction with, or online, stem. For example:

- What you would need to know about in order to make an informed decision whether to accept it to manage access to, or online resources or applications?
- What you would need to know about in order to see content provided it

The reason this definition is important is to distinguish between the set of people who might have a credential that, on the one hand, is issued by the set of those people who are within, or derivative of, the membership of the committee, or the people in common
